NCDOT seeking public input on STIP scoring

The N.C. Department of Transportation is asking the public to provide feedback on the quantitative scores and preliminary local input points assignments for the transportation projects for the upcoming State Transportation Improvement Program (STIP). The STIP document is developed under the Strategic Transportation Investments law (STI), which established the Strategic Mobility Formula. In fall 2015, NCDOT and local planning organizations assembled and submitted projects for scoring after collecting public input for the 2018-2027 STIP. NCDOT is hosting 15 information sessions across the state between June 20 and July 14, to receive input on the locally identified priorities and points assignments methodologies that will result in a Draft STIP next year. Local governments play a critical role in shaping community health through the services they provide, among them: drinking water, public safety, parks, and planning. However, the growing complexity of public health requires innovative service delivery approaches, collaboration, and partnerships. ICMA's new report "Improving Quality of Life: The Effect of Aligning Local Service Delivery and Public Health Goals" seeks to advance the conversation about viewing and managing general local government infrastructure, transportation systems, water and sanitation, land use and planning, and other services as part of broader efforts to contribute to a healthy environment and support healthy lifestyles. NC Broadband Infrastructure Information Technology Technical Assistance Program

High-speed internet, or broadband, is universally recognized as an essential asset to attract and retain businesses, prepare a digitally ready workforce, and improve government efficiency. However, significant challenges in broadband deployment and adoption remain for many in North Carolina's cities and counties. To address these local challenges, NC Broadband's Technical Assistance Program provides communities with an on-the-ground technical support team to work with communities across the state to provide needed broadband expertise. Specifically, the Technical Assistant Team partners with willing communities to develop local objectives and plans in order to do the following: 1) Understand current broadband availability. 2) Locate unserved and underserved businesses and residents. 3) Identify assets relevant to broadband deployment. 4) Build partnerships with broadband service providers; and; 5) Identify opportunities to leverage assets, reduce barriers and help make the business case. Gov. McCrory releases State Broadband Plan

The plan finds that new technologies, user demand, and greater reliance on internet access will require ongoing infrastructure upgrades within our state. Governments can ensure a healthier broadband ecosystem by encouraging competition through updated policies and laws. In areas where competition is lacking, policy makers must empower communities to form more equitable partnerships with service providers. Developed by the Broadband Infrastructure Office within the North Carolina Department of Information Technology, the plan offers lawmakers and local officials specific recommendations to foster broadband deployment and adoption. A collaborative effort, the plan uses feedback gathered from more than a dozen stakeholder listening sessions, discussions with nearly 80 subject matter experts, and a survey of 3,500 local leaders. North Carolinians across the state are using broadband to improve their education, their businesses and their lives. Jane Boahn, CEO and Founder of Raised in a Barn Farm was able to reposition and grow as a result of her ability to redevelop their offerings, from a tobacco farm into a farmer's market and community venue that hosts weddings, birthday parties, live music, hay rides, and much more and utilizes broadband for payment processing, advertising, marketing, and more in rural Chocowinity, NC. USDA seeks applications for broadband grants for rural communities

USDA is soliciting applications for grants to establish broadband in unserved rural communities through its Community Connect program. Community Connect is administered by USDA's Rural Utilities Service and helps to fund broadband deployment into rural communities where it is not economically viable for private sector providers to provide service. USDA plans to award up to \$11.7 million in grants through the Community Connect grant program. The grants fund broadband infrastructure to help foster economic growth by delivering connectivity to the global marketplace. The grants also fund broadband for community centers and public institutions. The minimum grant is \$100,000 for FY 2016. The maximum award is \$3 million. To view rules, click [here](#). Transportation Bill [H959](#)

Bill H959 recommended changes by the JLOTC (Joint Legislative Transportation Oversight Committee) regarding local consultation on small transportation projects, turnpike authority, broadband in right of way and bicycle and pedestrian records. Passed House on June 2, 2016 and Senate transportation committee substitute adopted on June 15, 2016. The Senate Transportation Committee approved a Proposed Committee Substitute (PCS) that would make a few tweaks to the version that was passed by the house—of note, the Senate version would add a requirement for a “reflex mirror” on the rear of a bicycle used at night (in addition to the front and rear lights required in the House version), and would remove the language about NCDOT doing a bike safety education program. Other changes as well: removes language from house version about cost of utility relocations, adds language about weight limits for construction equipment, removes section on DOT surveying changes, changes to Turnpike reporting requirements, additional requirements related to DMV use of email for notifications, removes section about delaying participation in electronic lien system, additional language about release of public record accident reports, and additional language about use of Freight Rail & Rail Crossing Safety Improvement Fund for assistance to short line railroads. Kerr-Tar Workforce Development Board to apply for America's Promise Job-Driven Grant Program

Funding is available to support grants under the America's Promise Job-Driven Grant Program. ETA expects to fund between 20-40 grants, with individual grants ranging from \$1 million to \$6 million. This competitive grant program will build on the momentum of WOIA to develop and expand regional partnerships and training opportunities, particularly for middle-to-high skilled H-1B industries and occupations, ensuring that communities fully maximize their federal, state and local funds to build a competitive workforce. Advocacy Alert: U.S. Senate Votes
to Cut State Health Insurance
Program Funding

The Senate Labor-Health and Human Services measure that recently passed out of the full Appropriations Committee would zero out the State Health Insurance Assistance Program (SHIP). In our state, the program is called North Carolina State Health Insurance Information Program (SHIIP). Eliminating SHIPs would leave millions who need support comparing coverage options, appealing denials, applying for financial assistance, and navigating increasingly complex Medicare benefits stranded—with nowhere to turn. In 2015, the SHIIP program helped North Carolina Medicare beneficiaries save \$53 million in Medicare coverage and prescription drugs. This is more than the \$52.1 million that is appropriated for all SHIPs nationwide and is being eliminated in the current U.S. Senate Appropriations Budget. North Carolina SHIIP is the only organization in the state that provides unbiased, accurate, highly-personalized one-on-one counseling about Medicare by phone and in-person in all 100 counties in North Carolina. In 2015, in the Kerr Tar region, more than 1,830 consumers were counseled; Saving nearly \$563,000 by these individuals. The Kerr Tar Area Agency on Aging staff and several aging service provider staff are certified SHIIP volunteers who counsel beneficiaries through complex Medicare options. Kerr-Tar Area on Aging Four Year Plan Approved

The NC Division of Aging and Adult Services approved the Kerr Tar Area Plan. The “Plan” is effective from July 1, 2016 – June 30, 2020. The Division’s Reviews Team conducted a thorough review of the plan and determined that it is comprehensive and recognizes the efforts by the Area Agency on Aging to improve access to services and promotes the well being of older adults, caregivers and their families. The Review Team identified the plan’s strength’s to increase capacity for outreach to caregivers and minority populations in the region.
