**Kerr-Tar Regional Transportation Project Prioritization (P3.0):** *Michael Ciriello, Director, KT Planning/RPO*  
Scoring Methodology

Mike advised that the North Carolina legislature and NC Department of Transportation (NCDOT) require all regional transportation planning organizations (rural and metropolitan) to develop a *local ranking process* for projects across all modes of transportation (highway, bicycle/pedestrian, public transit, aviation, rail, and ferry). The local ranking process was submitted to the NCDOT's Strategic Prioritization Office of Transportation (SPOT) for their review and comment. The local ranking process was submitted to the KTRPO's members at the March 27, 2014 meeting to ensure compliance with the legislative mandate. The TAC approved methodology will be made available to the public for a period of public comment consistent with the KTRPO Public Involvement Plan (PIP).

**Applicability:** This process applies to all projects ranked by Kerr-Tar RPO in Person, Granville, Vance, Warren or Franklin counties that are ranked as "regional" or "division" funding level projects. Funding levels are defined in the 2013 Strategic Transportation Investments law.

**Local Point Assignment Methodologies:** The KTRPO submitted its proposed Prioritization methodology to NCDOT and to KTRPO TAC/TCC members in December 2013. Comments were received from NCDOT in early January 2014 and incorporated into the revision resubmitted in mid-January. A copy of the Methodology with NCDOT comments and the revised document was presented the TAC/TCC in mid-January and posted on the KTRPO website ([www.ktrpo.com](http://www.ktrpo.com)) for public comment. Pending NCDOT review and approval, the KTRPO

TAC/TCC will approve the KTRPO point assignment methodologies described herein at the March 27, 2014 TAC/TCC meeting.

The TCC and TAC members made the following recommendations:

Highway KTRPO FY2014 Planning Work Program Amendment  
Maximum 100 Points item

- Criteria Crash Frequency changed from 20 % to 25 %
- Development strategy changed from 20% to 10%
- Destination served changed from 20% to 25%
- Direct access to at least from one to two
- Need more than 1 transit supportive and facilities

Project Ranking: The TCC and TAC will evaluate the full list of new and previously-evaluated projects for our five counties from March to July 2014 at the June 19<sup>th</sup> meeting. Final approval, point assignment, and submission to the SPOT office will occur 90 days after the release of scores by the SPOT office.
