- Conducts research, identifies, and communicates with program staff in development of new public and private grant opportunities consistent with organizational priorities and KTWDB capacity;
- Develops, organizes and supports innovative strategies and special projects to better engage and serve the participation of unique populations across programs in workforce activities;
- Works in conjunction with other KTWDB programs as needed to assure that all customers obtain quality workforce training and employment assistance services;
- Directs daily operations of KTLRC programs to ensure quality client services in compliance with federal and state eligibility and performance requirements, budget guidelines, and stated outcomes.

Graduation from an accredited college or university with an Associate's degree in human services, non-profit management or related field and two years of experience; or an equivalent combination of experience or training.
