The CEDS is a requirement from the US Department of Commerce, Economic Development Administration and must be submitted every five (5) years. The COG sincerely thanks the members of the CEDS Committee for their participation throughout this process.

North Carolina Lakes District Bike Plan

The COG plans to release maps of the North Carolina Lakes District Bicycle Plan later this month. This plan will connect the region through a series of interconnected bike paths, making note of the areas amenities and natural resources. The NCLD Bike Plan received approval previously from the COG's Transportation Advisory & Technical Coordinating Committees, Executive Board, and all five regional Boards of County Commissioners.

Revised Draft 17/18 STIP

The NCDOT just released the Revised Draft 2018-2027 STIP on June 28,2017.

The Revised Draft 2018-2027 STIP is now available on NCDOT's website at

This is an updated version of the state's draft 10-year transportation plan that was released in January. The plan was revised based on updated revenue projections and now includes an additional 144 projects totaling \$2.5 billion.

Kerr-Tar RPO committed projects in our Draft Division and Regional Programmed Projects that made it into the REVISED Draft 2018-2027 STIP are listed below. Please note that we have three more projects moving into the committed category, meaning that they are programmed for Right-of-Way or Construction in the first five years (2018-2022) of the 2018-2027 STIP.

The committed transportation projects in the Kerr-Tar RPO now total in excess of \$100,000,000.

There are 15 new transportation projects funded in Division 5(Kerr-Tar RPO is part of Division 5). The NCDOT will hold a public comment period on the updated version of the document. The public comment period on the 2018-2027 Revised Draft STIP runs from June 28 to July 12, 2017. It is anticipated that the NCDOT Board of Transportation will approve the 2018-2027 STIP in August 2017.

Consider a Living Healthy Workshop

If you have conditions such as diabetes, arthritis, high blood pressure, heart disease, chronic pain, anxiety, and/or depression, the Living Healthy Workshop can help you take charge of your life.

Classes will be held every Wednesday from July 12- August 16, 2017 at the Granville County Senior Center from 2pm to 4:30pm. There is no cost to sign up but registration is required. All participants receive a Health book and CD.

Matter of Balance Class

A Matter of Balance Class will be held at the South Granville Senior Center, starting in August 2017. For more information, please call the senior center at (919) 528-0848.

A Matter of Balance is designed to reduce the fear of falling and increase activity levels among older adults. Participants learn to set realistic goals to increase activity, change their environment to reduce fall risk factors, and learn simple exercises to increase strength and balance.

Healthy Eating Classes Completed

The Kerr Tar AAA has wrapped up the \$2,500 Triangle North Health Foundation Grant for Healthy Eating for Older Adults. Healthy Eating[™] is a program for seniors age 60 and better who want to learn more about how nutrition and lifestyle changes can promote better health. The program focuses on heart and bone healthy nutrition strategies to help maintain or improve wellness and prevent chronic disease development or progression. Jillian Hardin and Melissa Catlett facilitated two six week workshops beginning in May at the Granville County Senior Center in Oxford. It ended with a trip to a restaurant where participants used what they learned to order and enjoy a healthy meal. The AAA is also calling for local Lay Leaders who are interested in leading classes in their community! If you or your staff is interested in becoming trained as a lay leader call the AAA.



Scam Jam

On June 14, the Kerr Tar Area Agency on Aging with the Person County Senior Center conducted a Scam Jam to help educate seniors to protect themselves from frauds and scams. This was a free educational and entertaining forum where seniors will learned to avoid todays scams and frauds, from identity theft to telemarketing and consumer and Medicare frauds. Speakers included representatives from the Senior Medicare Patrol from the North Carolina Department of Insurance, North Carolina Attorney General's Office, North Carolina Department of the Secretary of State as well as local Law Enforcement. Thirty participants attended this event at the Person Count Center in Roxboro, NC.



Elder Abuse Walk

The third Annual Elder Abuse Awareness Walk on June 15th at Sothern Vance High school sponsored by the Kerr Tar Area Agency on Aging and Vance County Department of Social Services put a spotlight on the mistreatment of the elderly and provided information on how to prevent it. According to the North Carolina



Division of Aging and Adult Services, in 2013 there were over 20,000 reports alleging the abuse, neglect or exploitation in North Carolina to County DSS offices. Of those, 70% were 60 years or older, 15% lived in a facility or shelter, and 85% lived alone or with family. 'It is through events like the Elder Abuse Awareness Walk where we hope to educate the community to end or at least know the signs of abuse so we can report suspected

cases and help our older adults live in their community of choice for as long as possible with improved quality of life," says Jillian Hardin, Director, Kerr Tar Area Agency on Aging. Close to two hundred participants walked to raise awareness. Attendees had the opportunity to visit with vendors, attend presentations, win prizes and enjoy lunch. Everyone left armed with information and resources on how to spot and prevent elder abuse.

Lowes Heroes

The Kerr Tar AAA teamed up with Lowes Home Improvement for its Lowes Heroes program. This year, we are reaching out to the Home Delivered Meals clients to educate this underserved population on Elder Abuse Awareness and Summer Heat Safety. On the morning of June 30th, the AAA staff worked alongside Lowes volunteers to assemble Heat Emergency Kits. The kit included items such as instant cold packs, flashlights, batteries, first aide kits, dust masks, and water. Lowes volunteer drivers delivered the kits to the service providers that afternoon. Jillian Hardin, AAA Director coordinated with the home delivered meals volunteers in Granville County to follow a route and helped deliver kits to clients in Stovall. AAA Staff and HDM volunteers will continue to deliver the Heat Emergency Kits to the remaining counties in the upcoming weeks.

The Kerr Tar AAA held its 3rd annual Volunteer Appreciation Luncheon at the Henderson County Club on June 30th. Over 70 volunteers attended the event, which featured a delicious lunch, an inspiring message delivered by Doug Jenkins of Granville County and a special recognition for Melissa Catlett's 10 years of continuous service. 
