2017 NCHFA Urgent Repair Program Housing Repair Assistance

The Kerr-Tar Regional Council of Governments (COG) has been awarded \$100,000 by the North Carolina Housing Finance Agency (NCHFA) under the 2017 cycle of the Urgent Repair Program to assist residents in the counties of Franklin, Granville, Person, Vance

and Warren. The Urgent Repair program finances emergency home repairs for homeowners who are elderly or have special needs and whose incomes are below 50% of the median for the area. Only repairs that address imminent threats to the life and/or safety of occupants of the dwelling unit or accessibility modifications will be performed under the program. A total of 13 households are projected to be assisted.

In the Urgent Repair Program, one or two critical problems may be repaired, but the entire house is not addressed. Examples of work typically done under this program include roof or HVAC system repair, well or septic system repairs, adding accessibility features like ramps, bathroom grab bars and wider doors.

The COG will provide assistance, to those whose homes are selected for repairs, in the form of a loan. Homeowners will receive an unsecured deferred, interest-free loan, forgiven at a rate of \$1,000 per year until the principal

balance is reduced to zero. The maximum amount of the loan available is \$8,000.

Applications are available starting July 1, 2017 and must be returned to the COG office by 5:00pm on September 1, 2017. Clients to be assisted will be selected by November 1, 2017. Click here for the application.

Duke Energy Selects Franklin County Site for Economic Development Program

Duke Energy has selected six North Carolina properties for participation in the first half of its 2017 Site Readiness Program to prepare them for business and industrial development.

The Site Readiness Program has helped prepare properties that have won 11 major projects in North Carolina since the program started in 2005, resulting in more than 2,400 new jobs and \$3.3 billion in capital investment.

Through the program, Duke Energy identifies high-quality industrial sites and partners with county officials and local economic development professionals to develop a strategy for providing water, sewer, natural gas and electricity to the properties.

"This program shines a light on high-quality industrial sites across the state, and enables communities, especially in rural areas, to attract jobs and build thriving economies," said John Geib, North Carolina economic development director for Duke Energy. "We're committed to continuing these efforts that help build stronger communities and ultimately, a stronger North Carolina."

The Watson Farm site is a 278-acre parcel located between Youngsville and Franklinton on Highway U.S. 1 North in Franklin County. The site has excellent potential for industrial development and can be rail served. "The Duke Energy Site Readiness Program provides an excellent opportunity to have a professional site assessment performed by a nationally recognized site consultant firm," said Richie Duncan, director of Franklin County Economic Development. "The findings will enable us to identify key attributes of the site in order to help us better compete for industrial and manufacturing projects in the future."

Site consulting firm McCallum Sweeney Consulting will evaluate the site.

Based on consultant recommendations, Duke Energy will collaborate with county leaders and local economic development professionals to develop an improved strategy for marketing the sites.

Additionally, each site is eligible to apply for a \$10,000 matching grant from Duke Energy to help prepare it to attract projects.

After each site's state of readiness has advanced, Duke Energy's business development team strategically markets each of them nationwide to companies looking to expand or relocate their operations.

"We understand the important role our company plays in the economic development landscape, and we work diligently to keep our rates competitive," Geib said. "North Carolina can better compete for business investment, growth and jobs with reliable electricity and affordable energy prices."

Duke Energy's economic development efforts are perennially recognized by *Site Selection* magazine in the publication's annual list of "Top Utilities in Economic Development." Through these efforts, Duke Energy helped recruit \$2.2 billion in capital investment in North Carolina and more than 5,500 jobs for the state in 2016.

Kerr-Tar TAC/TCC Meeting

Meeting is **Thursday Anguet 29, 2019** from 3-5pm at the KTCOG office. We are currently in the process of compiling our projects for Prioritization P5.0 in all transportation modes with several meetings of the P5 Subcommittee. The first P5 Subcommittee took place on July 25, with another meeting scheduled for August 15, 2017. The P5 Subcommittee is composed of the Planner from each Kerr-Tar RPO county, the KARTS and PATS Directors, the Division 5 Planning Engineer, the Kerr-Tar RPO Coordinator and the Kerr-Tar Planning Director. At the upcoming August 25 TAC/TCC meeting, members will look at these proposals so far. We will discuss the Kerr-Tar projects in all modes as well as the Alternate Criteria proposed for Region C and Division 5. Kerr-Tar RPO is allowed to submit up to 21 projects in each transportation mode.

Additional TAC/TCC Meeting Scheduled

Kerr-Tar TAC/TCC will meet on **Elemetry September 21**. Meeting is from 3-5pm at the KTCOG office. This meeting has been scheduled in case the TAC/TCC needs more time to consider and approve the Kerr-Tar highway project submittals and alternate criteria by the NCDOT deadline of September 29, 2017.

Water Quality Management Workshop

Kert-Tar Regional Council of Governments in conjunction with Upper Coastal Piedmont Council will be hosting a Water Quality Management workshop on August 22 at the Warren County Armory and Civic Center. This workshop, will focus on furthering the knowledge, understanding, involvement, and contribution of interested parties in the mid-North Carolina portions of the Roanoke River Basin. Short and long-term sustainable resource management solutions for the RRB will be studied, with specific emphasis on Smith and Newman's Creek. This workshop is possible through a Water Quality Management Planning Grant.





The COG hosted its final CEDS meeting in July. The meeting concluded with finalizing a Vision Statement for the region and identifying specific strategies and goals in order to increase economic activity throughout the reigon. A draft copy of the CEDS will be presented at the August 24 Board of Directors meeting and submitted to EDA for review in September. The COG sincerely thanks our regional partners for their work in completing this process.
