
# **BOARD MEMBER SPOTLIGHT:**

# **ARP TECHNICAL ASSISTANCE SESSIONS**


As a joint collaboration between the NC Association of County Commissioners and the Governor's Task Force on Racial Equity in Criminal Justice, there will be a series of sessions focusing on responding more appropriately to calls for emergency service, specifically those concerning mental illness, autism, intellectual disabilities, substance abuse, homelessness, and other non-emergency situations.

The expert panelists will detail how American Rescue Plan (ARP) funding offers an opportunity for local governments to implement crisis response teams, co-responder teams, and alternate responder models to respond to calls for service. # **MUNICIPAL WATER QUALITY TRAINING**

The Council of Governments will be hosting a Water Quality Training for its municipal governments on **July 19 at 2:00 pm** at the COG Office. This training will be facilitated by staff at the NC Department of Environmental Quality – Division of Water Infrastructure. The topics to be discussed include: the State's Water and Wastewater Master Plan and the new Viable Utility Program. The COG is encouraging interested municipalities to attend. ### GRANVILLE COUNTY RECEIVES SPR FUNDING

Granville County has been awarded State Planning and Research funds from the North Carolina Department of Transportation to begin a Feasibility Study along the Butner and Oxford portions of the East Coast Greenway. Work on the feasibility study is expected to begin in the fall of 2021. The KTRPO will provide the Towns of Butner and Oxford with periodic updates on the study.

## **US DOT RAISE GRANT**

The KTRPO will serve as the lead applicant for a Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant, formerly the BUILD Grant through the US Department of Transportation. The RPO, working with the East Coast Greenway have identified between 20-40 miles of potential bikeway within Granville County. The East Coast Greenway is a bike route that stretches from Maine to Florida. This grant application is due later this month.

# **PASSAGE OF HOUSE BILL 130**


On Friday, June 25, Governor Cooper signed House Bill 130 (now Session Law 2021-54) designating the East Coast Greenway as a State Trail. This legislation overwhelmingly passed both chambers. Following this designation, the East Coast Greenway will be eligible for a variety of funding mechanisms and other forms of support for trail planning and construction in North Carolina.

Speaking on the passage of HB 130, East Coast Greenway Virginia & North Carolina Manager Sarah Sanford stated: "This recognition by the North Carolina State Parks system is a tremendous step for the East Coast Greenway in the state."

Speaking at the bill signing in Raleigh, Governor Cooper stated: "Designating this trail as part of the State Parks system will ensure that we continue to develop and maintain these important resources for all North Carolinians. It is vital to the health and well-being of our state's residents that public outdoor spaces are available to everyone, in every community." The KTRPO is presently partnering with the East Coast Greenway on applying for a RAISE Grant through the US Department of Transportation.

# ARCHIE TAYLOR NAMED 2021 CITIZEN OF THE YEAR



Please join us in congratulating Vance County Commissioner Col. Archie B. Taylor, Jr. for being designated the 2021 Citizen of the Year by the Henderson-Vance County Chamber of Commerce.

His selection was announced at the 83rd Annual Meeting of the Chamber. Col. Taylor is described as a "small-town diplomat" and a "roll-up-your-sleeves worker." His volunteerism includes his support of education, the arts, Boy Scouts, Maria Parham Health and other community institutions.

In the area of education, his involvement with the Vance County Public School Foundation, the local school system, and Henderson Collegiate Charter School were noted. Evidence of Taylor's service to the Boy Scouts was his designation several years ago as the George Rose Watkins Citizen of the Year by the Occoneechee Council of the Boy Scouts.

Fellow Vance County Commissioner, Tommy Hester, Jr., said of the recognition: "He's done an outstanding job of promoting Vance County and Henderson. He works hard for every citizen of the County." Henderson-Vance Economic Development Board Member, Ruxton Bobbitt, has had an opportunity to see Taylor's impact on the economic well-being of the County and stated: "He's one of the most cooperative people to sit down and listen to what people need and the County needs."

We congratulate Col. Taylor on receiving this honor and thank him for his service to this country and commitment to Vance County.

# **CERRI UPDATE**

The North Carolina Department of Commerce has begun its Community Economic Recovery and Resiliency Initiative (CERRI) program with the initial 10 communities. Warren County, located in the state's North Central Prosperity Zone began conducting meetings in June. The CERRI process will involve residents and business owners. The COG looks forward to serving as a Community Partner and working with Department of Commerce planners in this initiative. Other identified communities within the Kerr-Tar Region will begin the CERRI process at various times.

### RECONVENING OF THE COUNCIL ON UNDERSERVED COMMUNITIES

On June 22, the US Small Business Administration announced the agency's reconvening of the Council on Underserved Communities under the authority of the Federal Advisory Committee Act. The restoration of the Council will help support the SBA's prioritization of equity across its programs and initiatives. The Council will consist of 20 diverse stakeholders from every region of the country tasked with advising the SBA on strengthening and improving its strategies to help underserved communities. SBA

The Council on Underserved Communities was established to focus on communities and populations that have traditionally faced barriers in accessing credit, capital and other resources necessary to start and grow businesses.



### EMERGENCY BROADBAND BENEFIT INFO SESSION

The Emergency Broadband Benefit is a temporary program that provides a discount of up to \$50 or \$75 per month to lower the cost of broadband service for low-income households. To help spread the word in North Carolina communities, the State Library and the Broadband Infrastructure Office of NCDIT are offering an online information session for front-line staff on Friday, July 9 at 1:30 pm. Attendees will receive an overview of the program, and will learn who is eligible, how individuals can sign up, and practical outreach strategies and materials. The session will end with an opportunity to ask questions.
