### AMERICAN RESCUE PLAN ACT OF 2021

With the passage of the American Rescue Plan in March of 2021, non-entitlement municipalities in North Carolina municipalities will be receiving funds from the state's Pandemic Recovery Office. All sixteen municipalities in the Kerr-Tar region have been awarded a specific allotment of funds. It is the intent of the Council of Governments to conduct a training for municipalities on potential uses for ARP Funds.

#### **OPEN FOR BUSINESS LOAN**

We know that small and local businesses have been hit hard as a result of COVID-19 and we want to help. The Open for Business Loan Program is designed to help small to medium size businesses recover from the economic pandemic. Funds are intended for use as working capital (rent, payroll, utilities) and/or equipment during shutdown and re-opening.

To apply, simply visit <u>www.kerrtarcog.org</u>, click on the Open for Business Loan tab at the top of the page, and complete the application.

#### **Loan Details**

- 5-10 year, interest free loans
- Non-forgivable loans ranging from \$10,000-\$100,000
- Must demonstrate a direct loss of revenue as a result of COVID-19
- Can be used for working capital and/or equipment



Funds are administered locally and funded federally by the US Department of Commerce, Economic Development Administration with funds from the Coronavirus Aid, Relief, and Economic Security (CARES) Act.
