Updated Visitation Policy for LTC

Facilities

On November 19, the NC Department of Health & Human Services posted revised <u>COVID-19 Infection Prevention</u> <u>Guidance for all Long-Term Care Facilities</u>. This guidance applies to all long-term care facilities including nursing homes, assisted living facilities, and adult care homes. There is a VERY important section on visitation: "Facilities must allow indoor visitation at all times." CMS changed their guidance for nursing facilities on 11/12/21.



Many residents and families have been looking forward to visitation over the upcoming holidays, especially after no contact last year at this time. Please be sure to read through the NC guidance and CMS guidance carefully. Contact your loved one's facility prior to any planned visitation and be prepared to share these documents with them. If you encounter any facility limitations imposed outside of the guidance given in these two documents, contact Kim Hawkins, Kerr-Tar Regional Ombudsman at 252-436-2050. If you continue to encounter visitation restrictions outside of those allowed in the new guidance, file a complaint with the Division of Health Services Regulation via their complaint hotline: 1-800-624-3004. You can remain anonymous.

Emergency Regulation Requiring COVID-19 Vaccination for Health Care Workers

The Biden-Harris Administration is requiring COVID-19 vaccination of eligible staff at health care facilities that participate in the Medicare and Medicaid programs. The emergency regulation issued by the Centers for Medicare & Medicaid Services (CMS) protects those fighting this virus on the front lines while also delivering assurances to individuals and their families that they will be protected when seeking care. Frozen Food Company to Invest \$5 Million in Oxford

Meel Corp, a frozen food company, will create 24 new jobs in Granville County, Governor Roy Cooper announced. The company will invest \$5.7 million to relocate a production facility in Oxford. "We are glad to welcome Meel Corp to North Carolina," said Governor Cooper. "Our state has the best business climate, the hardest working employees, the agricultural legacy, the central east coast location and the great quality of life that will make this company successful here."



Headquartered in Miami, Meel Corp supplies healthy frozen foods through its own brand and private labels. For more than 40 years, the family-owned business has sourced, developed, processed, and packed organic and conventional fruits, vegetables, and frozen convenience products. Meel's expansion to North Carolina will include a state-of-the-art packing and cold storage facility and will continue to source some products from North Carolina.

"We're beyond excited about our move to North Carolina. With the supply chain plagues and labor issues that surfaced after COVID, North Carolina represents and ideal geographical location for us--bringing us closer to our national customers and their delivery points," said Michael Iaslovits, President of Meel Corp. "Our company name--MEEL is an assembly of the first letters of our family members--we're happy to bring our family business to North Carolina, where we will hire new employees and expand our family!"

Although wages will vary by position, the average annual salary for all new positions is \$48,500 and will create a potential payroll impact of nearly \$1.2 million per year. Granville County's average annual salary is \$42,326. To read more about this expansion, click <u>HERE</u>.

NC Commerce Secretary Visits Person Co. Mega Park

On November 15, NC Commerce Secretary Machelle Sanders, Assistant Secretary of Rural Economic Development Kenny Flowers, and an entourage of fellow Commerce and Office of State Budget and Management staff visited Person County for an update and tour of the Person County Mega Park.

Chairman of the Person County Board of Commissioners Gordon Powell, EDC Chairman Phillip Allen, and City of Roxboro Mayor Merilyn Newell participated in the visit along with EDC Ex Officios Brooks Lockhart, City Manager, and Dr. Rodney Peterson, Superintendent of Person County Schools. The group heard a presentation of the history and overview of the site, insights gleaned from heightened project activity, and continued development needs from ED Director Sherry Wilborn.

Following the presentation, Wilborn, Allen, and Assistant ED Director

Mike Thibault took the group on a tour of the site. In 2018, NC Commerce awarded Person County a \$1.6 million grant to construct a waterline to the site. Construction of the 12" waterline, capable of supplying up to 2.5 million gallons per day of water to the site, was completed in 2020.




New Staff Member: Joyia Evans

Two Local Schools Participate in Walk to School Day

Previous Safe Routes to School Program Coordinator, Kisha High assisted in coordinating with EM Rollins STEAM Academy and Pinkston Elementary School in joining schools around the world in celebrating Walk to School Day. Walk to School Day, held annually in October is a global event that involves communities from more than 40 countries walking to school. This event began in 1997 as a one-day event and over time, this event has become part of a movement for year-round safe routes to school and a celebration promoting increased physical activity.



Regional Resilience Portfolio Program

The Kerr-Tar COG has collaborated with the North Carolina Office of Recovery and Resiliency's Regions Innovating for Strong Economies and Environment to produce a Regional Resilience Portfolio Program to develop a vulnerability assessment and a portfolio of priority resilience projects that reduce risk and increase resilience in the Kerr-Tar region. A local community leader selected to serve as a facilitator leading this effort has been identified: Chalis Sledge, Executive Director of Turning Point Community Development Corporation. A Stakeholder Partnership composed of individuals or groups representing Emergency Management, Public Safety, Elected Officials, Municipal Government Administration, Public Health, and Nonprofits has been identified. The portfolio program will combine analysis and planning in the following steps:



VGCC Entrepreneurship & Innovation Center

Vance-Granville Community College's Entrepreneurship & Innovation Center (EIC) is open for business. Students and community members attended the ribbon-cutting ceremony hosted by the Granville County Chamber of Commerce on November 9 to mark this momentous occasion. The event coincided with Global Entrepreneurship Week. The EIC is located at VGCC's South Campus in Creedmoor. While housed at the South Campus, the Center serves those located in Franklin, Granville, Vance, and Warren Counties.

The EIC furthers VGCC's mission of strengthening the economy of North Carolina by helping rural NC young adult/adult students and clients achieve their entrepreneurial potential by exposing them to entrepreneurial thinking and entrepreneurial opportunities by connecting them with local mentors and entrepreneurial ecosystem partners. The outcomes directly relate to the College's mission of educating, inspiring, and supporting a diverse community of learners to achieve professional and personal success. 2023 Named NC Year of the Trail

In the recently approved State Budget (SB 105), the General Assembly appropriated funds to the North Carolina Department of Natural & Cultural Resources to support the North Carolina Trails System for the purposes of planning, construction, promotion, and maintenance of component trails in the State Trails System. The General Assembly intends for partnerships to be formed among local governments and nonprofit organizations. It is worth noting HB 554 (SL 2021–109) designates the year 2023 as "North Carolina Year of the Trail" and encourages all North Carolinians to take advantage of their local and regional trail networks, do their part to further enhance North Carolina's trail networks, and pay tribute to everyone who has labored to maintain and enlarge these public amenities.

To celebrate the "Year of the Trail," organizations and jurisdictions will offer special programming, festivals, and events highlighting and promoting all types of trails all across the State. The theme for the "Year of the Trail" has already been designated as North Carolina State Parks' annual focus for 2023, with programs, festivals, and events in all State Parks across North Carolina celebrating this theme.

Granville County Intersection Converted to All-Way Stop

The North Carolina Department of Transportation plans to modify the intersection of Bruce Garner (SR 1713) and Lawrence (SR 1710) Roads in southern Granville County. The intersection currently required vehicles to stop on Lawrence Road, but not on Bruce Garner Road. The Department plans to make the junction an all-way stop on November 30, 2021. An NCDOT investigation of traffic volumes and the number and severity of crashes warranted the change. Converting intersections into all-way stops has been shown to reduce fatalities and injuries by

77%.

These improvements are being made through NCDOT's SPOT Safety Program, which identifies safety projects that are expected to be the most beneficial and feasible and address departmental goals. People can visit the department's <u>all-way stop webpage</u> to learn more, including what to do when encountering one.



Why install an all-way stop sign?

- Improves safety while causing a minimal increase in travel time.
- Reduces the need for drivers to wait until there is a safe gap in opposing traffic.
- Are more predictable compared to traffic signals.
- Can serve as a temporary solution until a permanent improvement, such as a roundabout, can be funded and constructed.
- Are more cost-effective than other types of safety projects.



Criminal Record Expungement Event



The Kerr-Tar Workforce Development Board will be hosting a Criminal Record Expungement event where participants will receive FREE legal advice about criminal expungement. This event will be held at the Gateway Center, located at 314 S. Garnett St. in Henderson on **Tuesday, December 7 from 2:30-5:00 pm**.

There will be resources onsite for assistance with housing, transportation, and job placement. Please RSVP at kerrtarworks.com or call Kisha High at 252-436-2040. This event is presented by Legal Aid and hosted by Kerr-Tar Reentry Roundtable. KTWDB also hosted a Criminal Record Expungement Event in November with support agencies present to inform participants on housing, mental health services, and job placement. Person Co. Job Fair a Success!





2020 American Community Survey

What you need to know about the 2020 American Community Survey

The US Census Bureau announced in November that it would delay the release of the 5-Year ACS estimates that had been planned for December 2021. At present, the Bureau plans to release data for the 5-Year ACS in March 2022 but has not confirmed that it will be a standard release. They plan to provide more information in December.



Why the 5-Year ACS is important

The 5-Year ACS estimates provide detailed information for all geographies (down to the <u>block group level</u>). These combine the last five years of American Community Survey data for more accurate estimates of small areas. For example, the 2019 5-Year file until 2026 when the 2021-2025 5-Year file will be released.

NC Parks & Rec Trust Fund Grant Cycle

Parks & Recreation Trust Fund (PARTF) grants will be available in North Carolina in 2022 for local parks and recreation projects. Local governments in North Carolina are eligible to apply for the matching grants. PARTF grants can be used to acquire park land and build or renovate park facilities.

Local governments can request a maximum of \$500,000 with each application and must match the grant dollar-for-dollar.

About \$5 million was available last year for local government projects. This year's funding has yet to be determined.

Applications are due **May 2, 2022**.
