American Rescue Plan Act Compliance Audit

Leading into the new budget year, municipalities that have received their first portion of funding through the American Rescue Plan Act are required to submit an ARPA specific audit report. This report will verify compliance with the Final Rule issued by US Department of Treasury. Recommended steps for compliance audit preparation include:

1. Ensure that all policies and resolutions have been adopted prior to the obligation of funds
2. Ensure that all ARPA documents are effectively maintained, stored, and organized
3. Join the upcoming UNC School of Government Regular ARP/CSLFRF Office Hours (Zoom information, dates, and topics are listed below)
4. Ask questions! We are here to assist with your ARPA questions. As guidance develops we will continue to inform you of updates and recommendations.

A total of 10 facilities, 3 Community Advisory Committee members and 30+ residents were in attendance. ARPA Funding Update

With new funding from the American Rescue Plan Act, the Kerr-Tar Area Agency on Aging has plans to initiate several new programs to support the health and well-being of the region's older adults. KTAAA will partner with local medical practices and a community based organization to provide fresh fruits and vegetables to older adults who might not otherwise be able to obtain these valuable additions to a healthy diet. Additionally, KTAAA has plans to assist family caregivers with adult day services for their loved ones living with dementia or a related condition. KTAAA plans to work with Warren and Person Counties to provide accessibility ramps for older adults to be able to safely enter and exit their homes. Kerr-Tar RISE Update

The Kerr-Tar Regional Council of Governments is participating in the Regions Innovating for Strong Economies and Environment (RISE), through the North Carolina Office of Recovery and Resiliency to develop a portfolio of priority projects that strengthen regional resilience. Region K Stakeholders are invited to attend the NCORR RISE Kerr-Tar Region Stakeholder Partnership meeting, **Tuesday, July 12th from 10:30 am - 12:00 pm (virtual)**. This month, members will participate in an activity to rank proposed projects for the Project Portfolio. The final Portfolio will consist of 5-10 projects that are applicable within the region and address issues identified by the Vulnerability Assessment and through local experience. There will be opportunities following the meeting to provide your input if you are unable to attend.



NCDOT Division 5 Open House

NCDOT's Division 5 office will be open to questions from across our five county region during the week of **July 25-29**. The Division's office is located at 2612 North Duke Street in Durham. Division staff will be available to answer questions related to the **2024-2033 STIP**, status of regional transportation projects, and general transportation-related inquiries. The KTRPO is encouraging our member governments, members of the TAC and TCC, and residents to participate in this Open House.



Kerr-Tar Region Drone Project



The Kerr-Tar COG has collaborated with the Western Piedmont COG to supply each of the 5 Kerr-Tar counties drone footage of outdoor recreational amenities and areas of interest. The goal of this project was to highlight places and events that make each county a unique and attractive place to visit. The footage will be made available for each county to use, and the footage will also be used by the COG to market the region.

Clean Fuel Advanced Technology Grant



The primary purpose of the Clean Fuel Advanced Technology (CFAT) project is to reduce transportation related emissions in 24 eligible North Carolina counties. In the Kerr-Tar region, that includes Franklin, Granville, and Person counties. The basic criteria for eligibility are that the project is transportation related, reduces criteria pollutant emissions, and is located within or benefits a NAAQS maintenance area. There is one exception,

however: electric vehicle charging stations are eligible projects in all 100 counties of the state. Applications are due by **August 1, 2022**. More information on CFAT funding can be found [HERE](#). If you need application assistance, please contact us!

Help Shape the Future of North Carolina Transportation

Fuel tax has largely been responsible for a well-functioning transportation system that gets you to where you need to go, delivers packages to your door, and keeps groceries on the shelves. But as vehicles go farther on less fuel and some stop using any fuel at all, it becomes harder to maintain our transportation system.

The Eastern Transportation Coalition needs your help exploring an alternative approach to the traditional fuel tax, called a Mileage-Based User Fee, and determining if it would be a more equitable and sustainable approach. A Mileage-Based User Fee means drivers only pay for the miles they drive instead of the fuel they buy.

To better understand if this approach could work, the Coalition is conducting a pilot program in North Carolina and wants you to join and share what you think. What do you like? What do you think should change? It is free to participate, and there are strict privacy protection measures to safeguard your data. Here's how to join the pilot in four easy steps:

1. **Enroll:** Fill out the enrollment form by clicking the link on the website
2. **Insert:** Plug a small device into your vehicle to record mileage
3. **Drive:** Then drive as you normally do
4. **Return:** After a few months, mail back the device



*These steps may vary depending on the mileage-reporting option selected.

The NC Department of Transportation proposes to replace the bridge (Bridge Number 126) on Perrytown Road (SR 1116) over Phoebes Creek in Warren County. During construction, which is anticipated to last up to 12 months, the bridge will be replaced in its existing location, and an off-site detour will be required. The following construction is associated with STIP Number BP5.R112.

This event allowed over 50 youth ages 5-12 to show off their bicycle skills and learn about bike safety. Each participant received a free bike helmet courtesy of the 2022 NCDOT Bicycle Helmet Initiative. The Oxford Parks & Recreation Department applied for and was a recipient of the 2022 Bike Helmet Initiative.

Rural Transformation Grant Fund

Governor Roy Cooper announced in June that 30 local governments in rural areas across North Carolina have been awarded grants from the Rural Transformation Grant Fund, a new source of support for rural economic development projects in the state funded by the federal American Rescue Plan. The Rural Transformation Grant Fund awarded grants in 3 categories: 1) Downtown Revitalization, 2) Resilient Neighborhoods, and 3) Community Enhancements for Economic Growth.

Within the Kerr-Tar Region, the **City of Roxboro** received \$175,000 under the Downtown Revitalization category, and the **Town of Butner** and **Warren County** received \$825,000 and \$300,000 respectively under the Community Enhancements for Economic Growth category.

Age My Way NC Survey

A collaborative effort between the state of North Carolina and the largest representative of older adults in the state, AARP, will help our cities, towns, and rural areas become better prepared to meet the needs of an aging population.

"Age My Way NC" is surveying people age 45+ across the state to identify priorities such as safe and walkable streets, age-friendly housing and transportation options, access to needed services, and opportunities for residents of all ages to participate at home in community life. Approximately 1.7 million North Carolinians are age 65 or older, and that number is growing. By 2030, one in five will be older than 65 and for the first time ever, North Carolina will be comprised of more older adults than children.

Lisa Riegel, Manager of AARP North Carolina Advocacy & Livable Communities said, "Our state's aging population has become a cause for concern. With its expected growth, the nature of urban and rural development, daily living, work, leisure, and retirement are expected to change in order to keep pace." Riegel adds, "When it comes to making age-friendly improvements, what is good for older adults is also good for all residents. For example, better sidewalks and making areas more walkable not only improve health and mobility, they make main street businesses more accessible, and can even increase property value. Age-friendly investments have returns for all ages.

Mi Centro Bicycle Safety Class

On June 27, Safe Routes to School Program Coordinator Kenia Gomez-Jimenez brought an interactive bicycle safety experience to 65 Mi Centro students at Dabney Elementary School. Mi Centro is a three-week summer program through Vance County Schools that prepares upcoming Pre-K Latino students ages 4-5 for an English-speaking academic setting. Kenia taught the students about the many parts of a bicycle, why it's important to be visible when biking, as well as how wearing a bike helmet can save lives. The students also participated in other fun activities such as bike helmet decorating and traffic sign education. At the culmination of the class, each student received a certificate. The event concluded with all 65 students receiving free bicycle helmets, courtesy of Granville Vance Public Health. The helmets provided were supplied to GVHP through the 2022 NCDOT Bicycle Helmet Initiative.



Kerr-Tar Comprehensive Economic Development Strategy Update

The Kerr-Tar COG has retained the services of Sanford Holshouser Economic Development Consulting (SHEDC) to assist in the CEDS process, a requirement of the Economic Development Administration for Economic Development Districts nationwide. There are 4 main components of a CEDS: 1) summary background; 2) SWOT analysis; 3) strategic direction/action plan; and 4) evaluation framework. In addition to the components outlined previously, the contents of this year's CEDS will align with the agency's recently released Equity Action Plan. The COG and the SHEDC team will be hosting individual County Focus Groups throughout the region in the month of July. 

During her Work Experience, Ms. Bunton was exposed to the full range of responsibilities found in a busy office. She also mastered Microsoft Office, filing and organization, prioritizing, time management, and even cold calling. After completing her Work Experience, Huff was so pleased with her work that she was offered a promotion!

On June 17, 2022, Ms. Bunton started her On-The-Job (OJT) for the position of Human Resources Manager. Along with her previous skills, she will be learning the ins and outs of employment law, candidate vetting and selection, payroll, invoicing, negotiating future contracts, and making full use of the NCWorks Database for Employers.

When asked how she feels about her NCWorks experience, Ms. Bunton had this to say: "It is my job to share job resources and opportunities to help others also find rewarding careers."



Success Story: *Gwyneshia Green*



Gwyneshia Green, a single mother working part time as a customer service representative, was referred to NCWorks by Medical Careers Readiness. Ms. Green was seeking assistance with attaining her Phlebotomy license. She stated, "I have a goal of being a phlebotomist so I can provide for my children." On April 21, 2022 Ms. Green was enrolled in the WIOA program through NCWorks and began her training on April 25, 2022 with Medical Career Readiness. She successfully completed early due to receiving an employment offer from Maria Parham Hospital.

Success Story: *Zacchaeus Williams*



Zacchaeus Williams contacted NCWorks in June 2022 after becoming dispirited with his local employer, where promises of a decent wage and consistent hours never seemed to materialize. He has always liked working with his hands, especially building things, but has never had the opportunity to pursue this interest. His NCWorks NextGen program team created a four-day "Job Shadowing" opportunity at Robco Manufacturing of Henderson, NC, producers of high-end floating docks for Alumadock Marine Structures from June 14-17.

In this role, and under the guidance of Robco's seasoned professionals, Mr. Williams had a first-hand taste of the advanced manufacturing process, from blueprint to finished product. The folks at Robco were so impressed with his enthusiasm, reliability, and willingness to learn that they asked if he could stay!

On June 20, Mr. Williams started a Work Experience through NCWorks' NextGen program. Upon completion, he will have the skills needed, such as calculating material and equipment needs, soldering, MiG welding, metal reshaping, and final assembly to compete successfully in the growing field of Advanced Manufacturing. Prior to creating the Work Experience, his NCWorks team asked Mr. Williams if he was enjoying his Job Shadow at Robco, which was so different from his retail background. He grinned and said, "Oh yes! I am!"

Regional Job Fair Update: *Vance County*

On Friday, June 3, 2022 NCWorks and the Kerr-Tar Workforce Development Board held a job fair on Breckenridge Street in Vance County.
