### I. Roll Call of TCC & TAC to Establish Quorums

The meeting begins shortly after 3:00 pm. In order to recognize new members, the meeting begins with a roll call as well as introductions by each in attendance.

### II. Call the Meeting to Order – TCC Chair & TAC Chair

TCC Chair Baker calls the TCC meeting to order and TAC Chair Lane calls the TAC meeting to order.

### III. TCC/TAC Action Item I – Approval of January 27, 2022 Meeting Minutes

TCC Chair Baker recognizes the first order of business being approval of the January 27, 2022 TAC/TCC meeting minutes. TCC Chair Baker receives a motion to approve the January 27 meeting minutes as written from Brandon Jones. Lori Oakley seconded the motion and the motion carries unanimously.

TAC Chair Lane recognizes the first order of business being approval of the January 27, 2022 TAC/TCC meeting minutes. TAC Chair Lane receives a motion to approve the January 27 meeting minutes as written from Russ May. Gordon Wilder seconded the motion and the motion carries unanimously.

### IV. Presentation: Clean Transportation Program – John Bonitz, NCCETC

TCC Chair Baker recognizes John Bonitz, Clean Transportation Specialist, to present to the committees about the North Carolina Clean Energy Technology Center's (NCCETC) Clean Transportation Program. Mr. Bonitz provides an overview of the VW Settlement, Clean Fuels and Advanced Technology (CFAT), and other clean transportation programs. Mr. Bonitz then speaks about the need for a Clean Fuels Coalition throughout Eastern and Central North Carolina. Having been introduced to the idea, the RPO will decide at a later

date whether to support and join the Eastern and Central North Carolina Clean Fuels Coalition.

### V. FY 22 SPR Update

TCC Chair Baker recognizes Sam Boswell to give updates regarding the Granville County East Coast Greenway Feasibility Study. A summary of what has taken place in the study was provided in the agenda packet.

### VI. TAC Action Item II – USDOT RAISE FY 22 Resolution of Support

RPO Coordinator Sam Boswell informs the committees of the USDOT FY 2022 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant funding opportunity. The Kerr-Tar RPO has partnered with the East Coast Greenway Alliance to apply for funding to conduct a study for a multimodal greenway trail throughout portions of Granville, Vance, and Warren counties, including a segment along the S-Line rail corridor. As part of the application, the RPO requests a Resolution of Support from the TAC.

Hearing the request, TCC Chair Baker calls for a recommendation from the TCC. Justin Jorgenson motions and it is seconded by Cynthia Jones. All present TCC members vote in favor of recommending that the TAC pass a Resolution of the Support for the FY 22 RAISE Grant application.

Hearing the recommendation, TAC Chair Lane calls for a motion, which is made by Russ May and seconded by Emma Stewart. All TAC members vote in favor of signing the Resolution of Support.

The Resolution was signed by TAC Chair Lane after the meeting.

VII. State Ethics Commission Filing of SEI and RED Forms – Sam Boswell, RPO Coordinator TCC Chair Baker recognizes Sam Boswell to give an announcement regarding the NC State Ethics Commission, which is that TAC members (including alternates) are to file financial and real estate disclosures called the Statement of Economic Interest (SEI) form and Real Estate Disclosure (RED) form each. The due date is Monday, April 18, 2022.

TAC members desiring help with filing should contact Sam Boswell as soon as possible to schedule an appointment to complete the forms.

VIII. NCDOT Reports – NCDOT Division Engineer and Division Planning Engineer TCC Chair Baker recognizes Brandon Jones, Division 5 Engineer, to provide an NCDOT update. Mr. Jones announces that NCDOT is moving forward with signalizing the intersection of US 158 and Tabbs Creek Road in Granville County. In Vance County, the Burnside Bridge replacement is set to let by September 2022. In Warren County, the Eaton Ferry Bridge (over Lake Gaston) has had navigational lights for the waterway installed within the last month. Mr. Jones also calls attention to NCDOT's Spring Litter Sweep from April 16-30. At the request of TCC Chair Baker, Mr. Jones will obtain social media links and announcements that municipalities can use to inform community members. Many, including City of Roxboro/Person County, Town of Butner, and Warren County, have already made plans to participate in the Litter Sweep.

Mr. Jones also mentions that the Draft 2024-33 STIP should be coming out in April or May, at which point the RPO will receive detailed training concerning project swapping options. The final 2024-33 STIP should be prepared by December 2022.

TCC Chair Baker recognizes Bob Deaton, Division 5 Planning Engineer, to provide additional project updates. Mr. Deaton's updates align with the project memo provided in the agenda packet.

### **IX. Other Business**

TCC Chair Baker calls on RPO Coordinator Sam Boswell to provide information on other business for the committees.

• Bipartisan Infrastructure Law (BIL) Updates

Earlier in March, the Kerr-Tar COG partnered with Hal Hiemstra, a governmental affairs consultant, to hold an informational webinar on the Bipartisan Infrastructure Law and what it means for rural regions such as the Kerr-Tar region. The slides from that presentation were included in the agenda packet.

• CMAQ FY 23 Applications

The Kerr-Tar RPO has worked with the City of Roxboro to prepare a CMAQ application that calls for improved pedestrian infrastructure between Southern Middle School and South Elementary School. Specifically, this project is for sidewalk construction and signalized crosswalk improvements at the intersection of Southern Middle School Road and Hurdle Mills Road (S Main St).

• VW Mitigation Plan, Phase 2 – Current and Upcoming RFPs

There are currently several RFPs regarding the VW Mitigation Plan, including school bus replacements, transit bus replacements, heavy-duty equipment replacement, and electric vehicle charging infrastructure. Anyone with questions about any of the programs can contact the RPO for assistance.

 NCDOT 2022 Bicycle and Pedestrian Planning Grant Initiative
 NCDOT is now accepting applications for the 2022 Bicycle and Pedestrian Planning Grant Initiative. The program provides funding for municipalities and counties across the state to development comprehensive multimodal, bicycle or pedestrian plans. The deadline for applications is May 9, 2022. Anyone with questions should contact the RPO Coordinator.

Subject: Updates on NCDOT's Spring Litter Sweep

Each April and September, NCDOT asks volunteers to help remove litter from roadsides. Volunteers from local businesses, schools, nonprofits, churches, municipalities, law enforcement and community groups play an important role in keeping North Carolina's roads clean.

This year, community groups throughout the Kerr-Tar region rose to the occasion to keep the region's roads clean. We appreciate those who volunteered their time and energy to participate in NCDOT's Spring Litter Sweep.

The **City of Henderson** participated in litter sweep "Community Cleanup" on Saturday, April 23<sup>rd</sup>. The City along with several civic groups had over 100 volunteers participate and collected 1,560 lbs. of trash.

In **Franklin County**, E-911 Emergency Communications Department participated in litter sweep along T. Kemp Rd. to May Rd. along NC 56 Hwy (1.94 miles). The Emergency Communications Department was able to pick up 6 bags of trash and debris.

**Granville County** participated in litter sweep on Friday, April 22, 2022. Staff picked up 56 bags of litter on Oxford Loop Road in Oxford and Joe Peed Road in Creedmoor.

In **Person County**, PCEIAC and PC PRIDE participated in litter sweep and collected a total of 53 bags, 37 in the County and 16 in the City.



# How to apply for funding





#### Clean Heavy-Duty Equipment & Vehicle Replacement Program

Class 4: 14,001 to 16,000 lbs



Class 6: 19,501 to 26,000 lbs



Class 5: 16,001 to 19,500 lbs



Class 7: 26,001 to 33,000 lbs



Replacement of Class 4-7 local freight trucks, such as: delivery vans, bucket trucks, beverage delivery trucks, tow trucks and refuse trucks.

Vehicles eligible for replacement include those with engine model years 1992–2009.

Priority will be given to electric replacements.

Class 8: over 33,000 lbs





Replacement of Class 8 local freight and port trucks, including those used for hauling cargo to and from ports and intermodal rail yards, as well as freight or cargo delivery such as waste haulers, dump trucks and concrete mixers. *Priority will be given to electric replacements*.

#### School Bus and Transit Bus Replacement Programs







Replacement of a Class 4-8 School Bus, Shuttle Bus, or Transit Bus (vehicles with a Gross Vehicle Weight Rating (GVWR) greater than 14,001 lbs used for transporting people). Vehicles eligible replacement include those with engine model years prior to 2009. *Priority will be given to electric replacements.* 

#### DC Fast and Level 2 Programs



For the acquisition, installation, operation and maintenance of new light duty zero emission vehicle supply equipment. DC Fast includes public access, and Level 2 includes public access, workplace, multiunit dwellings and government complexes.

### **Diesel Emission Reduction Act (DERA) option**








DERA provides funding for projects that reduce emissions from existing diesel engines.

Authorized under the Energy Policy Act of 2005 and administered by U.S. EPA, DERA is designed to help replace or retrofit older, dirtier engines still in use with clean diesel or alternative fuel engines.

#### **Ferries and tugs**





Ferries or tugs equipped with unregulated, Tier 1, or Tier 2 marine engines may be repowered.

Ocean going vessels shorepower





Eligible marine shorepower systems provide electric auxiliary power from shore while a boat is docked to allow a vessel's engines to turn off and remain off while the vessel is at berth.





#### Airport ground support equipment

Supports fuel switching of diesel and gasoline airport ground support equipment. This type of equipment includes all vehicles and equipment used at airports to service aircraft between flights.

#### Forklifts and port cargo handling equipment



Replacement of forklifts and port cargo handling equipment. Eligible repower or replacement includes electric charging infrastructure.

### Level 2 Charging Station Projects cont.

### Publicly accessible project Application Period opens May 2, 2022—FIRST COME BASIS

Eligible applicants:

- Incorporated Nonprofit: an organization as described in section 501(c)(3) of the Federal Internal Revenue Code of 1954, as amended. The organization must be incorporated under NC law or registered with the NC Department of the Secretary of State.
- Public school districts.
- Municipal governments and municipal authorities.
- Tribal government agencies.
- Metropolitan or Rural Planning Organizations, as defined by the U.S. Department of Transportation at 49 U.S.C. § 5303(b), located in North Carolina.
- Businesses: corporations, partnerships, sole proprietorships, limited liability companies, business trusts or other legal business entities incorporated in or registered with the NC Department of the Secretary of State.
- Air Quality or Transportation Organizations: Local or regional air quality or transportation organizations that:
  - **own or operate a fleet located or operating predominately in North Carolina, or**
  - has partnered with or is acting as a project manager for another eligible entity listed in this section.
- Federal government agencies: Federal agencies that have custody, control, or management of land within or contiguous to the territorial boundaries of North Carolina

#### Workplace Charging

#### **Application Period NOT YET OPEN**

#### Eligible applicants:

Incorporated Nonprofits, Public school districts, Municipal governments and municipal authorities, Tribal government agencies, Metropolitan or Rural Planning Organizations, Businesses, Air Quality or Transportation Organizations, and Federal government agencies. Workplaces must serve sites with at least five or more year-round and full-time employees. If not publicly accessible, the site must not be reserved for any specific employees. If publicly accessible, the site must be convenient for users of the charging station and have nearby amenities or some likelihood of use by members of the public.

#### **Multi-Unit Dwellings**

### **Application Period NOT YET OPEN**

#### Eligible applicants:


Homeowner's associations, condominium association or residential real estate management association that may apply on behalf of a Multi-Unit Dwelling (MUD). A MUD must be a site with ten or more individual residential housing units within a single building or complex. This includes, but is not limited to, apartment buildings and condominiums, and excludes individually owned townhouses, row houses and mobile homes. Electric Vehicle (EV) charging sites at MUDs must be accessible to all residents with EVs.

### Applications Open for 2022 Bicycle and Pedestrian Planning Grants

**RALEIGH –** The N.C. Department of Transportation is accepting applications for the <u>2022 Bicycle and</u> <u>Pedestrian Planning Grant Initiative</u>. The program provides funding for municipalities and counties across the state to develop comprehensive multimodal, bicycle or pedestrian plans.

Communities can apply for a variety of plan options to meet specific needs, including multimodal, bicycle or pedestrian plans. In addition, the following options are available:

- Municipalities of all sizes and counties with populations of less than 100,000 with an existing bicycle or pedestrian plan may apply to update their plan if it is at least five years old.
- Municipalities with populations of less than 10,000 may apply for a Project Acceleration Plan an abbreviated plan that prioritizes project identification and implementation.

The deadline for applications, to be submitted electronically, is May 9 at 5 p.m. Award recipients will be notified by August.

This program is jointly sponsored by the department's Integrated Mobility Division (IMD) and the Transportation Planning Division. To date, \$7.5 million has been awarded to 238 municipalities and six counties across the state through this program.

Proposals are divided and judged in geographical groups to help establish equitable distribution of funding across the state. Selected recipients commonly include a diverse mix of municipalities from large cities to small towns.

Funded plans are not for one specific project but represent a comprehensive strategy for expanding bicycle and pedestrian opportunities within a community. The plans may address facilities, programs, policies and design guidelines that encourage safe walking and bicycling.

A <u>webinar</u> is scheduled for April 5, 2022, to provide more detailed information on the grant program and to answer questions from interested applicants.
