Item 3a: Administrative Tasks & Procedures

Item 5: KARTS Director Introduction

Background:

Randy Cantor is the newly appointed Executive Director of KARTS Transportation in Henderson NC. Bringing with him over 30 years of varying Public Transportation experience Mr. Cantor started his career in 1993 as a driver at LYNX in Orlando Florida. Being an Orlando FL, native, he quickly used his knowledge of the area and was promoted to Customer Service Supervisor for LYNX. Mr. Cantor furthered his career with LYNX by becoming their Planning Supervisor in 2000 and taking on his most challenging role yet as Para-Transit Operations Manager in 2003.

Mr. Cantor used his role as Operations Manager to relocate to Murphy NC and became the Director of Cherokee County Transit in 2010. His time spent in Cherokee helped their transit system flourish and Mr. Cantor was once again off to find his next "challenge".

Mr. Cantor took on his next adventure in Carteret County NC in 2013 as the Director of Carteret County Transit, County Garage, and Transportation Coordinator for the EOC in its active duration.

With his abundant amount of knowledge in Public Transit, Local Government, and Grant Procurement he has recently moved to Vance County NC to take on the position of Executive Director of Kerr Area Transportation Authority.

When Mr. Cantor isn't in the office using his knowledge to help transit systems grow, he spends his time camping and traveling with his wife of 30 years. He enjoys trips going to visit his two daughters and three (soon to be four) grandchildren.

Item 6: DCHC-MPO Introduction

Background:

The Durham-Chapel Hill-Carrboro Metropolitan Planning Organization (DCHC-MPO) is the regional organization responsible for transportation planning for the western part of the Research Triangle area in North Carolina. The DCHC-MPO is an umbrella organization comprised of the MPO Board, the Technical Committee (TC), local governments, and the State. The MPO Board, designated by the Governor, is a policy body that coordinates and makes decisions on transportation planning issues.

The DCHC urbanized area includes:

- Durham County (entire county)
- A portion of Orange County including the Towns of Chapel Hill, Carrboro, and Hillsborough
- Northeast Chatham County

Additionally, DCHC is also one of the ten urban areas in North Carolina designated as a Transportation Management Area (TMA). TMA's are urban areas with a population of over 200,000 people.

Durham County is part of Division 5 and shares borders with both Person and Granville Counties.

Recommendation:

Item 7a: Prioritization 7.0 Draft Slate of Projects

Background:

The project list below is a draft of Kerr-Tar RPO's recommended projects and is subject to change. Some projects have been added since the TCC meeting on July 20, 2023. KTRPO has 21 project submittal slots per mode. As of now, we have used 8 Aviation slots, 10 Bicycle/Pedestrian slots, 20 Highway slots, 19 Rail slots, and 4 Transit slots. It is the RPO's recommendation to accept all projects until **September 15**, **2023** to fill any remaining slots per mode.

Notes to keep in mind:

- This is a snapshot in time:
 - o Only accounts for estimates and bid awards at this time
 - O We have to assume the same look back at last cycle
- It **can** and **will** change by the time our STIP managers start programming the 2026-2035 STIP
- A variety of factors affect these numbers:
 - \$700 million in increases (cost estimates, additional authorizations and bid award adjustments) in committed projects since we locked down the STIP in March ahead of the June adoption

- Some buckets had almost all their projects committed. This means less available funding for new projects.
- There's also cases where a project may be committed with ROW starting in the last year (2028) and CON starting around 2031. That means the next 2 years we pick up in the STIP, are heavy cash flow years (2034 and 2035)
- One last item to keep in mind, the funding availability shown is relative to 0% over programmed. We are allowed to go up to 10% over and we use that as necessary when programming. On average, the Division needs buckets were about 7% over programmed in this last STIP.

Recommendation:

Item 7b: FY 2024 PWP Amendment #1

Background:

NCDOT has increased the allocation for Fiscal Year 2024 Planning Work Program from \$139,186 to \$160,100. The RPO recommends budget increases in a few of the categories including Prioritization due to it being a Prioritization round, Programmatic Direct Charges to allow the RPO to purchase GIS software and conduct GIS-related work, and finally Indirect Costs due to increases incurred by the program. At this time, the RPO recommends increasing the cost to other categories to allow more work in these areas, however, it may need to be amended in the future; for example, the RPO is working with NCDOT to determine whether or not updated Comprehensive Transportation Plans will be conducted this fiscal year.

Recommendation:

Approval of the budget amendment. Included in the Consent Agenda.

VOLUNTEER SAFETY RULES AND GUIDELINES

- Park in areas that: provide safe entrance and exit of the pickup area; do not create hazards with other vehicles and equipment operating near the work area; and provide maximum protection for volunteers getting in and out of the vehicle.
- All volunteers must wear a NCDOT approved orange safety vest. It is a good practice to wear long-sleeve shirts, gloves and high-top boots to protect against unforeseen hazards.
- Take extra precautions to prevent heat and cold stress when working in extreme temperatures. Pick up only during daylight hours and stop work during inclement weather.
- Face oncoming traffic while on foot. Stay off the road at least five feet from the pavement edge.
- Do not pick up in ditches, tunnels, on road surfaces, bridges, overpasses or medians. Avoid any construction areas.
- ▶ Work in small groups, allowing ample space for each volunteer to work safely.
- ▶ Place tools in a safe position so that sharp points are not exposed.
- ▶ Be aware of hidden obstructions that may have sharp edges and broken glass, especially in grassy areas.
- Do not attempt to squeeze bags to make room for more trash. Use caution when handling trash bags containing broken or sharp objects. Use proper lifting techniques when lifting bags.

- Do not pick up what appears to be hazardous material or any type of container with unknown contents (notify your local coordinator or NCDOT maintenance office if you encounter hazardous objects or holes, guy wires and other hidden obstacles in the ground.)
- ▶ Place trash bags where they can be easily retrieved by NCDOT personnel, but well clear of roadway traffic.
- Do not use or possess illegal drugs or alcohol prior to or during a cleanup.
- ▶ Provide adequate supervision by one or more adults 21 years of age or older for groups that have volunteers 12-17 years of age. All volunteers must be at least 12 years of age with adult supervision to participate.
- ▶Know the routes to medical care in case of emergency and have a first-aid kit readily available.
- ▶ Conduct a safety meeting for all volunteers prior to each cleanup and go over all safety procedures, rules and guidelines. View the "North Carolina Adopt-A-Highway Safety" video and the "Colorado Meth Lab Waste Recognition" video prior to participating in a cleanup.
